## GMAS BUILDING FUND – AIR-CONDITIONING THE SCHOOL

As you may be aware from previous correspondence over the years and the annual fee brochures, the funds received from the Building Levy families pay each year are directed to servicing loans for new building construction and refurbishments. The voluntary contributions made to the GMAS Building Fund further assists the School to reduce the funds it would otherwise need to borrow.

The most difficult financial matter the School Council faces is sourcing funds for building development. There are some government grants and loans but most of the funds have to be borrowed from a financial institution at the prevailing rate. We normally commit to paying off the capital and interest of each loan over the following 15 years.

Recently the School Council has undertaken a program of building that has seen vast improvements in the facilities with a new Early Childhood Centre, new Junior and Senior School classrooms and two new playgrounds (installed late May 2016). The School has a fine purpose built array of buildings, both specialist and general, that cater for the needs of our students across the four phases of learning.

The School is now planning to air-condition all buildings from our early building stages over the next few years. Retrofitting air-conditioners is an expensive exercise, but necessary for our school population. The process of air-conditioning the school will involve a large power supply upgrade and improvements to the thermal insulation of the buildings.

The GMAS Building Fund currently has approximately \$100,000 in the account. These funds together with any new donations to the GMAS Building Fund and the funds raised by the P&FA will be used for the purpose of air-conditioning the school. The sooner we raise the necessary funds, the sooner we can air-condition the whole school.


